
1 The Company has adopted Indian Accounting Standards (Ind AS) as prescribed under Section 133 of the Companies Act, 2013 with effect from 1st April 2017. Accordingly, the financial results for the quarter ended 30th June 2018 and the corresponding quarters has been prepared following applicable Ind AS.

- The Company Law Board (CLB) passed an order dated 10.3.2016 against which the Company filed an appeal before the Hon'ble High Court of Madras. The Hon'ble High Court vide its judgement dated 4.7.2017 set aside the order of the CLB to the extent, it directs purchase of equity stake by the Company. The Hon'ble High court further directed that the Company shall not transfer and/or create a third party interest in its immovable assets. Against the order of the Hon'ble High Court of Madras, the company filed a SLP before the Hon'ble Supreme Court of India. The Honourable Supreme Court while disposing of the SLP filed by the Company, in its order dated 10.05.2018 and 17.05.2018, directed that the Company to buy the shares of respondents 1 to 6 at the price of Rs.100 Crores within a period of 9 months from the date of the order. On payment, the share capital of the Company shall stand reduced by virtue of the order. The Hon'ble court further held that the buy back of share will not trigger the SEBI Takeover Regulations. The observations of the High Court will not bind in any other proceedings between the parties.

The Hon'ble Supreme Court of India has also held that the sale of immovable property to implement the buy-back and the consequent reduction in share capital shall not be subject to any liability under Income Tax Act, 1961.
