- ii. Pass an order permitting the Applicant to cancel the 18.98% shares of Respondent No. 2 Mr. S. Natarajan (through his wife and group companies) presently held by the Escrow Agent in terms of this Hon'ble Court's Order dt. 17.05.2018 in SLP (Civil) Nos. 22089-22090 of 2017 and SLP (Civil) Nos. 22708-22710 of 2017;
- iii. Pass any such other order that this Hon'ble Court may deem fit and proper."
